Notice: WCA Constitution Amendment

This constitutes notice that a vote of the membership will be taken.

A motion was passed that called for adding the Westwood boundaries to the WCA constitution. In order to make this amendment, we intend to vote on the following wording during the August 19, 2014 General Meeting. Passage requires a two-thirds vote of the membership present. We will have reference maps available during the meeting.

Physical boundaries of Westwood

Westwood, the largest neighborhood in the City of Cincinnati, is located in the Northwest portion of the city and is bounded as follows:

Traveling northwest on Harrison Avenue, Westwood begins at Hansford place and extends south through the wooded area to Queen City Avenue. Westwood includes the streets of Carnes, Champlaign, High and Tille which run north off Queen City. The boundary includes the north side of Queen City Avenue and extends west on Queen City Avenue to Sunset Avenue. The border then runs south on Sunset Avenue, including the west side of the B & O railway (since removed) and extends south and west to include the Dunham Recreation Complex. As the B & O railway crosses Boudinot, the Westwood boundary extends south on Crookshank Avenue, and includes the west side of Crookshank Avenue to the city limit boundary with Green Township. Westwood borders Green Township and the city of Cheviot on its western extremity. Westwood's northern border continues from the city limit, through Mt. Airy Forest, to the west fork of the Mill Creek, where it is separated from the neighborhoods of Mount Airy and Northside, on the "north side" of the creek. From the intersection of Montana and the west fork of the Mill Creek, Westwood Northern Boulevard and McHenry Avenue. The eastern border of Westwood extends from McHenry and Westwood Northern Boulevard in a southern direction to include the streets of Cavanaugh, Atlin, Costello, Ruberg, Baker, Robert, Pickmeyer, St. Leo Place and North & South Teralta. From Baker and Harrison, the boundary then joins Harrison and Hansford to complete the border.

Coalition Presents Square Options August 19 Mary Jenkins

Westwood Civic Association has invited Westwood Coalition representatives to present Westwood Square options at the August 19 general meeting as a continuation of the community discussion begun on June 12 and attended by more than 110 people. Regional Narcotics Unit (RENU)

The Regional Narcotics Unit is a multi-jurisdictional drug task force that is comprised of Narcotics Agents from the Hamilton County Sheriff's Office, Cincinnati Police Department, Green Township Police Department and Anderson Township. This unit is designed to investigate criminal organizations and individuals primarily responsible for the illegal trafficking of controlled substances in the Greater Cincinnati area through the operation of investigative programs, including but not limited to, drug intelligence, drug interdiction and undercover operatives. The Regional Narcotics Unit also assists local, state and federal law enforcement agencies when requested.

WW Civic Tall Grass Report

The Westwood Civic Association appointed a member to communicate with the City of Cincinnati about the tall grass and weed situation in our community. You can register a complaint about tall grass and weeds by the following methods:

In the process of filing a complaint you must identify:

- 1. Private Property the Health Department follows up.
- 2. Publicly Owned Property the Public Services Department follows up.

To speed up the complaint process and eventual mowing:

- Make your complaints as soon as the errant property approaches 10 inches of tall grass/weeds.
- Please try to properly designate the property type (Public or Private)

Our volunteer uncovered the following interesting facts:

- 17% of all complaints in the 6 months ending 7/15/14 have been mowed by the owner (40).
- It is unclear how many have been mowed by the City of Cincinnati's Contractor (looks like 3 but told closer to 15).
- It appears that Public Services may not be following appropriate procedures for the paperwork e.g. for the 6 months ending 7/15/14 every Property designated as Public (45)still carries a "NEW" designation complaint 5/6/2014). Of these many are Private Property (12). The Health Department is now following up on the Private Properties and informing Public Services of their duties to process the Public Property complaints, which may or may not be in the queue for mowing (more next month).
- Many of the complaints are duplicate because, no surprise, there may not be enough of a budget to keep up with mowing by the City Contractor in a timely manner if the property owner remains negligent.
- While there are quite a few properties still to be mowed, Westwood has the City's ear on this issue. We have been assured that the next list of properties to be mowed by the contractor will include a good portion of Westwood properties.

In conclusion, Westwood Civic will continue to work with appropriate city officials, and if needed, City Council, to address this issue in our community. We pledge to start earlier in 2015 to remind our citizens of the complaint process and do official follow ups with city officials.

Gamble Montessori High School Celebrates Renovation with Community Ribbon Cutting on Tuesday, September 30th at 6 PM

Have you ever wondered what was happening with all of the work at the Gamble School Building? Did you attend school at Gamble and wanted to reacquaint yourself with the building? Here is your opportunity to check out the building and program of one of the gems in Cincinnati Public Schools. Westwood resident Jack M. Jose, Principal of the James N. Gamble Montessori High School, invites the community to the official ribbon cutting ceremony at 6 PM on Tuesday, September 30th. After the ceremony, you are encouraged to stay for tours of the school and performances of the musical groups.

Officials from the School District, the school, the City of Cincinnati and Westwood will be participating in the ribbon cutting to commemorate the conclusion of a two year, \$6 million renovation that concentrated on utility efficiencies. The work also included important infrastructure updates including replacing the curbing and increasing the parking at the school, improving school safety and security, and providing state-of-the-art technology in the classrooms including wireless internet and integrated computer access. Community members, staff, students and families also embarked on a renovation of the auditorium seats that required no taxpayer dollars, and helped prepare the auditorium for another half century of use.

James N. Gamble Montessori High School is entering its tenth year of educating Montessori students, having been started as part of Dater Montessori nine years ago. The school moved back to Westwood, into this building for the 2013-14 school year while the building was still undergoing the renovation.

Some interesting facts about James N. Gamble Montessori High School include:

- * Gamble was rated **Excellent** by Ohio Department of Education in 2012, making them one of the **top two high schools** in Cincinnati Public Schools in **academic performance** (Walnut Hills and Gamble Montessori)
- * Gamble was one of two CPS high schools to have a **National Merit Scholar** in 2012 (Walnut Hills and Gamble Montessori) and the ONLY high school in <u>Greater Cincinnati</u> to have a **Gates Millennium Scholar** in 2012
- * Gamble proudly serves students who have a **wide range** of abilities and challenges, including learning disabled, autistic, and academically gifted students; core high school classes are advanced (**AA**) classes
- * Gamble students regularly participate in field experiences that include travel, community service, intensive learning, and meaningful reflection. 8th graders travel to Pigeon Key Florida for an 8-day immersive marine biology experience.
- * Gamble students have access to AP classes and are eligible for the state of Ohio's Post-Secondary Enrollment Options Program, allowing them to earn both high school AND **free college credit** for classes taken at UC or Xavier University

Gamble asks you to join in the celebration on September 30th. Parking is available onsite with overflow parking a short walk away at the Ryan Field CRC lot. The school is located at 2700 Felicity Place.



Westwood's White Rabbit

When replying to the question *What is Westwood's Number 1 Problem?*, some might guess "foreclosed properties" or "crime." Others might say "absentee landlords" or "poor zoning." Still others might say the 2010 HUD Community Challenge Grant with its twin goals of "high density" and "affordable" housing that the City is using to plan and fund Westwood Square. After fourteen years of patrolling with Westwood Citizens on Patrol, my answer is "complacency."

While Westwood's community infrastructure is robust with the Westwood Civic Association, Westwood Historical Society, Westwood Community Urban Redevelopment Corporation, and Westwood Works, the total number of members or volunteers in these organizations is less than 1,000 people. With Westwood's population topping out at 29,950, that means that only 2.9% of its residents are involved in making their neighborhood a better place to live. That statistic defines *complacency* or "a feeling of contentment or self-satisfaction, especially when coupled with an unawareness of danger, trouble, or controversy."

Getting involved, however, doesn't necessarily mean joining an organization or running for office. It means picking up the litter on your street, calling in suspicious activity to the Cincinnati Police Dept. (765-1212), notifying Duke Energy for burned -out streetlights, and adopting a vacant lot or abandoned property. It might also mean starting up a Block-Watch in your neighborhood, holding a block party, or organizing a litter cleanup.

Lewis Carroll lampooned the problem of complacency in *Alice in Wonderland*. The White Rabbit gets so excited and confused when Alice grows so tall that she breaks through the roof of his house, he says to a bystander, "Don't just do something, stand there!" We laugh, knowing he meant to say, "Don't just stand there, do something!"




