They would also like to have speakers present to the youth on different topics.

  - 4. Revisit the Neighborhood Strategic Plan (10 years old) WCA can take a lead on revisiting this plan. It is available on the website. John Kerr is interested in participating on a committee for this.

- 5. Problem Properties In the past, Joel had a list of problem properties and used it to get the city involved in a solution. This committee will need to focus on this.

- 4. Membership and Outreach (Emily Reynolds) Ad campaign to push membership. Postcards, Facebook ads have been done to get new members. Plans to do canvasing in the future. Emily suggests getting a photo of the board to post of the website. It would be helpful to have a brochure/flyer sharing information about why to join Westwood Civic. We are at about 210 members, with a goal to get to 350 by the end of the year.
