

## Westwood Uniting to Stop the Violence needs Leaders!

Westwood Uniting is an initiative of the Westwood Civic Association.
We are looking to engage more Westwood residents in working collaboratively with neighbors, stakeholders, and the police department in maintaining a safe quality of life for Westwood. The Westwood Civic Association Board of Directors is proposing an amendment to the organization's bylaws. The purpose of the proposed change is to reduce the cost, time and effort associated with annual board elections by moving away from a mailed ballot process to a process that includes a combination of in-person and on-line voting options. By eliminating cost and effort, the Board feels that this change will encourage that elections take place in the future and encourage nominating committees to throw out the net more broadly and encourage more residents to run for board positions in the future. New Board members bring new ideas and serve to refresh the Board. Other than how voting is done, nothing else in the process would be changed. Below, you'll find the proposed new language for Article X in the bylaws, which addresses elections. The highlighted text below reflects the proposed changes. If you'd like to review the current wording, please visit <a href="www.westwoodcivic.org">www.westwoodcivic.org</a>, select Governance from the menu and then click the "bylaws" link.

This amendment will be voted on, by members, at the November 17 General Membership meeting which will begin at 7:00 p.m. You can either attend via Zoom (Meeting ID: 859 4046 9773, Password: 1868) or cast your vote in person at the outdoor Muse Café tent area in Town Hall Park. A couple of Board members will be there to support in-person socially-distanced voting. While all are welcome to attend, only current WCA members will be able to vote. When we eventually resume in-person meetings, we plan to keep an online option like Zoom in place. These meetings are open to all those interested in being informed on what's going on in Westwood, or providing input on issues impacting Westwood. We hope to see you there!

#### **ARTICLE X- ELECTIONS**

**Section 10.01.** Eligibility for Election. Candidates eligible for election shall be members in good standing, as defined in §5.02, and shall not be in the class of Directors subject to the term limits provision (§6.06).

<u>Section 10.02.</u> <u>Nominating Committees.</u> At the November General Membership meeting, the President shall appoint one nominating committee and the members shall select a second nominating committee of not more than three members each, all of whom shall be members in good standing. Each nominating committee shall by majority vote select up to five candidates for the Board of Directors and present its selections at the January General Membership meeting. Members of the nominating committees are not barred from becoming nominees. As soon as the committees report, they are discharged from their duties.

<u>Section 10.03.</u> <u>Nominations from the Floor.</u> Nominations shall be allowed from the floor following the report of the nominating committees at the January General Membership meeting.

Section 10.04. Election Supervisor/Process. The two nominating committees shall select an Election Supervisor and shall announce that selection at the January General Membership meeting, as part of their report. The Election Supervisor shall be responsible for ensuring a list of candidates is communicated to members electronically, and notify members that an election will occur at the March General Membership meeting. Election Supervisor will invite candidates to speak at the February General Membership meeting. Election Supervisor will manage election process, with assistance from other Board members as needed, at the March General Membership meeting including printing, handing out, collecting and counting ballots and presenting results to members. Candidates shall be listed on ballot in alphabetical order by last name, with each member present at the March General Membership meeting able to vote for up to five candidates. In-person voting will be accompanied by an online voting option. At each January General Membership meeting, the Board of Directors will vote to confirm the online platform to be utilized. Online voting will close three days prior to the March General Membership meeting, so that online results can be tallied by the Election Supervisor prior to that meeting and then combined with in-person results before final results are announced at that meeting. Each member in good standing can only vote once, either in-person or online

<u>Section 10.05.</u> <u>Observers.</u> Any members in good standing may volunteer to serve as election process observers. Observers shall not disrupt the election process, but have the right to report perceived improprieties to the Election Supervisor and the President.

<u>Section 10.06.</u> Those <u>Flected.</u> Those five candidates who receive the highest number of votes shall be deemed elected and take office beginning with the April Steering meeting. Should there be a tie vote which results in more than the requisite number of candidates chosen, the tie shall be broken by a flip of the coin by the President at the March General Membership meeting in the presence of the membership.

<u>Section 10.07.</u> <u>Election of Officers.</u> The Board of Directors at the April Steering meeting, or prior thereto at a special meeting, shall elect, by secret ballot, the Officers of the Association from the members of the Board of Directors, except the Recording Secretary and Membership Secretary who can be any member in good standing.

At our recent volunteer work day, Julie Crossen planted her garlic cloves from garlic she had planted last fall and harvested earlier this year. Each clove will grow into a full head of garlic in the coming year. Thanks to all who helped with weeding, mulching the paths and adding a layer of straw to the cleared out beds that will protect the beds, suppress the weeds and eventually break down and help enrich the soil.

We also now have two very sturdy benches at our garden that we bought used from Coney Island that once had been in Moonlight Gardens. Stop by and sit a spell now in our garden to enjoy the view.


