7. Ty Gray Recognition – Elizabeth Bartley

Elizabeth Bartley: 2020 Neighborhood Summit was not held due to COVID, but Community Awards were selected. Elizabeth Bartley is bringing the awards to community award winners.

Pastor Tyrone Gray of Westwood was selected Community Award Winner-Community Catalyst of the Year specifically for his work with One Westwood initiative which seeks to bridge racial divide in the community.

8. DORA Signage Request – Larry Eiser

DORA boundaries requires clear signage. Requesting funding to support 25 vinyl 'sidewalk tattoos' to mark DORA boundaries @ \$16 apiece and about \$16-\$17 to install. Estimated total cost of ~\$900. DORA area will encompass space between Wondercade to Ivory House along Harrison Avenue. Businesses will pay for signage in their own windows/property. Will support continued activation of Westwood business district.

A couple of residents have concerns about having a DORA district, request more transparency and notification to residents in neighborhood about proposed implementation of a DORA in Westwood. Tom Sauter proposes that a separate discussion or forum is held on DORA to allow for more information and community feedback.

Funding request will be postponed until further discussion and potential DORA approval.

9. NSP Critical Deadline – Alexa Justice (Treasurer)

NSP deadline for expenditures is the end of September. Designated funds remain in our NSP account that still need to be spent.

She has tried repeatedly to discuss issue with Nation management and they've been unresponsive.

CPD has a dedicated parking enforcement group-Abe suggests calling parking enforcement specifically when;

Suggestion to have street parking designated for residents only.

Tom motions for WCA Board to investigate unlawful activities related to patronizing Nation; seconded by Nick.

Asking residents to provide documentation and evidence;

Amend motion to include investigation of new parking enforcement measures on Junietta. Seconded by Nick.

Motion passes.
